ACCEPTANCE OF TEMPORARY BUDGET FOR 2017

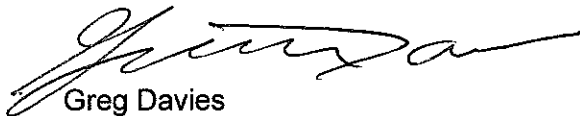
Whereas, NJSA 40A:14-78.17 provides for the adoption of a temporary budget for payments prior to adoption of a regular budget and approval by voters, and,
