<u>Call to Order:</u> The scheduled meeting of the Board of Fire Commissioners was called to order at 7:01 pm by Chairman Morehouse following proof of compliance with the Open Public Meetings Act. Notice was given through the Annual Meeting Notice and was filed with the municipal clerk, posted at the municipal building, the board's office, the fire district website, and advertised in the official newspapers of the district as required by law. Discussion held over bills and the progress of the utility truck build. The fate of the old utility was discussed and was noted that the truck will be auctioned unless the Township exercises their first right of refusal.

Bills were submitted to be paid from the 2024 budget for a total of \$109,829.50. Motioned by Commissioner Evans and seconded by Commissioner Blasi to pay the bills as submitted with a roll call vote all in the affirmative passing via majority. Resolution 2024-40 passed 3-0.
